Along with the application of Clever Fungus Ecosin we recommend cleaning the area that is in direct contact with the animal (kennel, bed, brush, collar etc.). This will prevent recontamination and speed up the recovery process by reducing the number of fungal spores in the environment.

Instructions for use: Hooves, claws

1. Dissolve 1 effervescent tablet in two litres of lukewarm water (about 34 °C) and let it activate for 20 to 30 minutes.
2. Apply directly to the affected areas either by wrapping the foot or by placing it into a basin/bucket.
3. Leave the foot wrapped for at least 20 minutes.
4. Allow claws and hooves to dry naturally.
5. Repeat all steps 1–3 three times a week. You can prolong the application as needed; there is no danger of overuse.

Once mixed with water, use the solution within 24 hours.

Do not use any other antifungal treatments or disinfection in conjunction with Clever Fungus Ecosin at least 5 days prior and 5 days post treatment.

Biomycosin Vet

Biomycosin Vet is a preparation applied in the form of a water based spray or water bath that has mycoparasitic effects in eliminating filamentous micromycetes and yeasts on the skin, hair and other skin derivatives, such as hooves.

It's applied on the livestock by spraying with special attention to the affected areas.

Application: In the form of a spray at a convenient time when the animal is calm and does not require special care or attention.

Spraying should be carried out from a distance of approximately 15-20 cm from the affected area. Follow the instructions for use.

Instructions for use:

1. Pour the contents of the jar into a spray bottle of approximately 15 litres. When preparing the solution, avoid inhalation of dust.
2. Add 15 litres of clean water and shake the solution well.
3. Using a sprayer, apply the solution all over the animal's body, taking particular care to treat the affected areas.
4. Apply once a day for the first five days, then as needed and as symptoms persist.
